## 2018-2019 Preschool Registration

Our Department of Child and Family Services (DCFS) licensed preschool program is for children 3, 4 and 5 years of age. We encourage the growth and development of your child at his/her individual level through varied activities and experiences. Our goal is to supplement and extend early home experiences in an environment planned to further your child's development through play and learning with their peers. Your child will have the opportunity to explore, discover and achieve in a relaxed atmosphere with qualified and concerned teachers serving as guides.

Our preschool schedule coincides with School District 45's school calendar, observing the same school holidays. Tuition fees are due on September 15, November 15, February 15 and March 15 for those paying in 4 installments and September 15 and February 15 for those paying in 2 installments. Monthly payments are not an option for paying preschool tuition.

**We require that all participants meet the age requirements (see below) and be able to use the restroom independently by the first day of school.**

### **AGE REQUIREMENTS**

3 YEAR OLD PROGRAM

Child must turn 3 years old by September 1, 2018

4 YEAR OLD PROGRAM

Child must turn 4 years old by September 1, 2018

#### ***Registrations must include the following:***

1. A completed registration form and signed waiver.
2. A copy of the child's birth certificate.
3. Non-Refundable \$97 registration fee.

Registrations will not be processed and will be returned if these items do not accompany your registration form or if all forms are not filled out completely. Please take your time and fill in all the blanks.
