**QUARTERLY PARKING PERMIT APPLICATION**

1. Complete the bottom portion accurately.
2. Be sure your Illinois license **plate #(s)** is correct and is **registered to your name and current address. (If your alternate vehicle is registered to a name other than yours, please write the owners last name in parenthesis after your last name).**
3. Return the bottom portion of this letter with your payment of **\$82.50** to the above address or place in the drop box in the Village Hall parking lot located on Home Ave. Applications will also be accepted in person at the Village Hall. Please indicate "train parking permit application" on the envelope.

**IMPORTANT:**

If your license plate # changes, you must notify us in writing within 24 hours of the change in order to avoid termination of your parking privilege. **Your permit must be displayed** conspicuously in the rear window of your car to avoid a parking ticket. Be sure to affix your permit securely\*. **If you are driving your alternate vehicle, you must display your sticker on this vehicle while parking in the permit area or you will receive a parking ticket.** \*When affixing sticker you may want to only peel half of the backing or place in a clear baggie and tape to the window for easy removal.

Permit parking spaces are **unnumbered and are located on the North side parking lot only.** Parking permits are not valid in numbered spaces. If you park your vehicle in **any numbered** space **you will receive a parking ticket!** These numbered spaces are reserved for daily coin parking only. There are only 240 permit parking spaces available. If the spots are sold out, your check will be returned and you will be placed on the waiting list for the next quarter.

Renewal applications are sent out approximately 4 weeks prior to the start of the new quarter.
