ADDENDUM AGREEMENT

This Addendum Agreement entered into this ____ day of _____, 2017
A.D., by and between the STATE OF ILLINOIS, acting by and through its
DEPARTMENT OF TRANSPORTATION hereinafter called the STATE, and the
VILLAGE OF VILLA PARK of the State of Illinois, hereinafter called the VILLAGE.

WITNESSETH:

WHEREAS, the STATE and the VILLAGE entered into an agreement executed
on April 19th, 2016, for the improvement of Illinois Route 38 from Summit Avenue to
Illinois Route 83, STATE Section (CY&543R)TS(14), State Job Number: C-91-236-
14, State Contract Number: 60X87, hereinafter referred to as the IMPROVEMENT;
and

WHEREAS, since the execution of the aforementioned Agreement the VILLAGE
has requested utility relocations to be added to this contract; and

WHEREAS, the STATE hereby agrees to the VILLAGE's request; and

WHEREAS, it is mutually agreed that the added relocations will be at 100% VILLAGE cost.

NOW THEREFORE BE IT AGREED that the aforementioned agreement is revised as follows as if fully incorporated therein:

Page 2, Item 3 of the agreement shall be revised to read as follows:

3. It is mutually agreed by and between the parties hereto that the estimated cost and cost proration for this improvement is as shown on the Revised Exhibit A attached hereto and made a part hereof.

REMAINDER OF PAGE INTENTIONALLY LEFT BLANK

Obligations of the STATE and the VILLAGE will cease immediately without penalty or further payment being required if, in any fiscal year, the Illinois General Assembly or Federal funding source fails to appropriate or otherwise make available funds for this contract.

This agreement and the covenants contained herein shall be null and void in the event the contract covering the construction work contemplated herein is not awarded within the three years subsequent to execution of the agreement.
