GENERAL INFORMATION REGARDING VENDING MACHINES AND AMUSEMENT DEVICES

VENDING MACHINES:

§ 13-416. Required.

No proprietor shall display a vending machine for operation by the public generally without having first obtained a vending machine license.

§ 13-401. Definitions.

Vending machine means any machine or device which upon the insertion of a coin, slug, token, plate or disk dispenses a product(s), commodity or item(s) of personal property and any machine where the operation of the device pays or gives consideration for the privilege of using the machines. "Vending Machines" as used in this article shall not mean "coin-operated amusement devices" as defined in Article III, section 40-301, stamp machines in United States Post Offices or coin-changing machines for no profit.

COIN-OPERATED AMUSEMENT DEVICES.

§ 4-301. Definitions

Coin-Operated amusement device means any machine or device which upon the insertion of a coin, slug, token, plate or disk may be operated by the public generally by manipulating special equipment whereby a score is established, the object of which is to secure a special number or numbers or a total score, whether a prize is offered or not, and any machines where the operator of the device pays or give consideration for privilege of using the amusement device. Each individual coin slot shall be considered a separate device.

§ 4-302. License Required

- (a) No person shall display for public patronage or keep for operation any coin-operated amusement device within the village without first having obtained a coin-operated amusement device license.
- (b) No supplier shall sell, place or keep or maintain any coin-operated amusement device within the village without first having obtained a coin-operated amusement device supplier's license . . .
- (c) It shall be unlawful for any person to place, keep maintain or purchase any coin-operated device from any person who does not possess a current coin-operated amusement device supplier's license.

If you are required to obtain the above licenses please call, the Village of Villa Park between the hours of 9:00 a.m. and 5:00 p.m. Monday through Friday regarding fees and licensing procedures. If vending machines are not licensed or the yearly license is not renewed on a timely basis you must advise your supplier to remove the machines immediately. The Village is not responsible for making arrangements with your supplier; therefore, their calls or questions will be directed to you.

NOTE:• If you allow non-for-profit organizations to place machines in your establishment, they are required to contact the Village and produce the non-for-profit documentation confirming that all proceeds will go to the registered non-for-profit organizations.
